- c. Homeowner Replacement of Landscaping Destroyed by Irma

- d. Discussion of Turf Complaints by residents and possible resolution Tempco explained that the turf in Portofino used and crabgrass are very closely related. There is no chemical that can selectively remove the crabgrass from the turf. There are preemergence chemicals that help to control crabgrass.
